Adapting IQAA to the rapid growth in the diversity of forms of education in educational programs



- Decrees of the President of the Republic of Kazakhstan No. 285 of March 15, 2020 and No. 306 of April 14, 2020 "On the introduction of a state of emergency in the Republic of Kazakhstan»
 - Orders of the Minister of education and science No. 108 of 14.03.2020 and No. 123 of 1.04.2020 "On strengthening measures to prevent the spread of COVID-19 coronavirus infection in educational institutions during the pandemic»




A state of emergency in the country and the quarantine mode:

cancellation of all flights, intercity trains and buses



- > Students in all higher education institutions of the country switch to distance learning from 14.03.2020;
- Faculty in all higher education institutions switch to distant mode of work;
- All types of assessment of students' learning, including the defense of theses (projects) are conducted online.

IQAA's response



Development of Guidelines for organizing and conducting hybrid and distant external review in the frames of institutional and specialized (program) accreditation.

Implementation of distance education by Kazakh universities



Most universities quickly adapted to the new format of teaching and learning thanks to their existing and already implemented electronic platforms for blended learning, such as ZOOM, Platonus, Moodle, Google class, Microsoft Teams, Cisco Webex, etc.

Examples of best practices from some universities

- ✓ Al-Farabi KazNU has developed the Univer 2.0 technology, which it uses together with Moodle
- ✓ Satbayev University has developed and uses its own Polytech Online platform
- ✓ Abai KazNPU uses the Univer system in accessible ICTs: Skype, Moodle, ZOOM, Google Classroom
- ✓ International IT University has a special laboratory for the preparation of digital content
- ✓ University of International Business offers free Coursera courses for students and faculty. Access to 3,800 courses and 400 specializations
- ✓ Caspian University offers online consultations for students 24/7 on the ZOOM platform
- ✓ Almaty Management University has been implementing its own MOOC system,

 OpenAlmaU, since 2016. During the pandemic, the University gave students access to all courses


